## Interpretation:

Molecular genetic analysis was performed for three specific mutations reported to be associated with disease in dogs. We identified two normal copies of the DNA sequences in three mutations tested. Thus, this dog is not at an increased risk for the diseases associated with these three mutations.

## **Recommendations:**

No mutations were identified. Thus, this dog is not at an increased risk for the diseases caused by or associated with the mutations tested. Because this dog is "clear" of these mutations, this dog will only pass the normal genes on to its offspring.
